FIRST INTERIM CLAIMS STATUS REPORT

Denise D. Dell-Powell, as Receiver for Wealth Pools International, Inc. and Recruit for Wealth, Inc. ("Wealth Pools") files this First Interim Claims Status Report as it pertains to the claims process. This is in accordance with the Order Establishing a Claims Procedure and a Claims Bar Date (Dkt. No. 88, the "Order") entered on March 20, 2008, which required the Receiver to file brief interim status reports regarding the matters authorized in that Order by April 21, 2008 and May 6, 2008.

1. In late March, 2008, the Receiver posted a copy of the Motion to Establish a Claims Procedure and a Claims Bar Date together with the Order and a notice and claim form on the Receiver's website at www.wealthpoolsreceiver.com. The notice and claim form is in English and Spanish.

2. Between March 28, 2008 and March 29, 2008, the Receiver mailed approximately twenty thousand (20,000) postcards to known potential claimants which notices provided the Claims Bar Date and information on how to obtain a Claim Form. These postcards included the above information in English and Spanish.

3. Prior to March 30, 2008, the Receiver provided e-mail notice to all potential claimants whose e-mail addresses were known to the Receiver, which notice included the Claims Bar Date and information on how to obtain a form in both English and Spanish.

4. The Receiver placed an advertisement to notify investors of the Claims Bar Date and how to obtain a form with USA Today which advertisement was published on April 3, 2008 and April 9, 2008. The advertisement was both in English and Spanish.

5. The Receiver placed an advertisement to notify investors of the Claims Bar Date and how to obtain a form with El Nuevo Dia which advertisement was published on April 3, 2008 and April 10, 2008. The advertisement was both in English and Spanish.

6. Finally, prior to March 30, 2008, the Receiver mailed a Claim Form to all known potential claimants that did not have e-mail addresses or access to the internet.

7. As of the date of this First Interim Claims Status Report, the Receiver has received approximately 2,000 claims.
